## JAMIE DIMON SAYS vs. JAMIE DIMON DOES

"The 'Dreamers' who came to America as undocumented children (there are approximately two million of them) should get a path to legal status and citizenship."

Under Dimon's leadership, JPMorgan Chase provides significant financing to the private prison companies that devastate undocumented families and cage their loved ones.<sup>2</sup>

The Trump administration should "end immediately the policy of separating accompanied minors from their parents. This practice is cruel and contrary to American values." Dimon currently heads the Business Roundtable which made this public call to end family separation at the border. He added his "heart goes out to the impacted families."

Continues to finance to private prison companies running the family and adult detention facilities where immigrant families are detained.<sup>6</sup> As of 2018, Chase holds over \$167 million in private prison company debt.<sup>7</sup>

"He is the President of the United States.

I believe he is the pilot flying our airplane [...]

I would try to help any President of the
United States because I'm a patriot."8

At Chase's 2017 annual shareholder meeting, Jamie Dimon said he would "look into" investors' concerns about Chase financing the private prison and detention industry.<sup>10</sup>

In this case, Dimon's words and action were consistent.

Dimon continued to serve as a member of Trump's Business Advisory Council until it eventually disbanded in 2017. This was following public outcry after Trump defended white supremacists at Charlottesville.9

Nothing. Chase has continued to finance private prisons for a year and half since that meeting.<sup>11</sup>
